

NatureNosh, LLC Privacy Statement

NatureNosh, LLC (hereinafter "NatureNosh") is firmly committed to protecting the privacy of its customers and those who sample NatureNosh products. NatureNosh is the sole owner of the information collected on this site. We will not share, sell, or otherwise distribute the financial or personal information of our customers or those who otherwise provide personal information to sample our products, to any other organizations in any way other than what is disclosed in this document.

All financial and personal information collected by NatureNosh is held in the strictest confidentiality. Any information, such as an email address, billing and shipping addresses, and other contact information, submitted via a download form, purchase form, or newsletter subscription, remains the sole property of NatureNosh. This information is used to help us process payment and to send registration information to our customers.

Personal information provided by customers, or those who sample NatureNosh products, is sometimes used to contact individuals regarding new information about NatureNosh products. If you decide you do not want to be contacted again by Two Great Danes, you can remove yourself from our mailing lists by sending an email to richard@nature-nosh.com with the words "Remove From Mailing List" in the subject line.

NatureNosh, will use a "cookie" in order to track website usage. These cookies do not collect personal information and are usually terminated once customers leave the site. These cookies record the time of your visit to the site, the date, the "referring" page that brought you to our site, and the IP address that your ISP has assigned to your computer at the time of your visit. This anonymous information is used to assist us in improving our website to create a better user experience.

When a purchase is made via the Internet with a credit card, NatureNosh uses a third party commerce service to verify credit card details. This company is sent the total price of the purchase, the card number and expiration date, and the cardholders name and billing address. All information transmitted to this third party is sent using SSL (Secure Socket Layer) encryption. Using this method of information encryption further insures the privacy and security of all our customers. This information is used only to verify the account and clear the transaction.

In some areas of the website, NatureNosh may choose to link to another website. We cannot be responsible for any of the content on these external sites. We are also not responsible for the privacy policies in place on that site.

To further protect the privacy of our customers, access to information by our employees is restricted within the company. Only select employees with an absolute need to use that information, in order to better serve customers, are able to view any personal details submitted. From time to time, NatureNosh will send out surveys and completing them are completely voluntary. The information gathered in these surveys helps us determine who our customer base

is and what their needs are. By compiling this data we can work to improve customer experiences with the company.
